2012 Red Hoffman Cup Matches Final Results

The Red Hoffman Cup Matches, completing their eighth year in 2012, were created to foster interaction and friendly competition among northern New Jersey's golf clubs. These matches have been named in honor of Arthur K. "Red" Hoffman, the legendary New Jersey golf writer. The event features no-handicap, match and medal play that effectively identifies the strongest team of players in one club in the region.

The 2012 Red Hoffman Cup Matches brought 24 clubs together in competition, up from 20 the year before. On each day of match play, 192 low handicap amateurs and club professionals competed. After three days of match play, the 2012 Champion was identified in an 18-hole, medal play finals among six clubs and 48 players on the Baltusrol Golf Club Upper Course.

Format for the first three days: two-man team, better-ball, match play; three-point (Nassau) scoring. Two matches are played at home and two away, simultaneously.
