

2013 Red Hoffman Cup Matches Final Results

The 2013 Red Hoffman Cup Matches were created to foster interaction and friendly competition among northern New Jersey golf clubs. Now in their ninth year, these matches have been named in honor of Arthur K. "Red" Hoffman, the legendary New Jersey golf writer. The event features no-handicap, match and medal play, four-ball competition that effectively identifies the strongest cohort of players in one club in Northern New Jersey.

The 2013 Red Hoffman Cup Matches brought 28 clubs together in competition, up from 24 the year before. On each day of match play, 224 low handicap amateurs and club professionals competed. Three days of match play identified the seven Finalists; their 56 players competed in an 18-hole, medal play finals on the storied Canoe Brook Country Club North Course.

**Format for the first three days of match play:** two-man team, better-ball, match play; three-point (Nassau) scoring. Two matches are played at home and two away, simultaneously.
